Election 2023

Labour have released [their manifesto](#). Some key points relevant to PTEs are:

- Prime Ministerial delegation to India within the first 100 days
- Continue the Strategic Recovery Plan for the International Education sector
- Pilot digital apprenticeships under the Digital Industry Transformation Plan
- Review the International Visitor Levy
- Further increase education and training pathways for disengaged youth
- Improve transition support for neuro diverse students moving between secondary schooling and tertiary education,
- Make the Apprenticeship Boost Initiative permanent
- Complete the implementation of RoVE
- Create a statutory right for workers to access vocational education
- Continue He Poutama Rangatahi with its focus on at-risk Māori,
- Continue to grow ACE,

National have not released their full manifesto but aspects of their [100-day plan](#) that are likely to impact PTEs include:

- Start reducing public sector expenditure by 6.5% on average by requiring Chief Executives to identify back-office spending not critical to frontline services
- Introduce legislation to restore 90-day trial periods for all businesses
- Begin disestablishing the Te Pūkenga polytech mega-merger and restoring local decision-making.

Their [international education plans](#) include:

- Fast track visa processing for international students who pay an additional fee.

- Increase the hours international students are able to work each week from 20 to 24.
- Expand work rights for international students and their partners
- Diversify the countries Education New Zealand recruits international students from.

Both National and Labour would keep fees-free, as would Greens. ACT would not

ITENZ Conference

Feedback from the ITENZ Conference shows it was another great success. Leaders from across PTE, VET, and international education sectors came together to discuss, question and collaborate on the future of PTEs and tertiary education over the two days in Christchurch.

TEC, Chief Executive, Tim Fowler, summed up the mood with a LinkedIn post on Day One. “Having a great day at the annual ITENZ conference in Christchurch. PTEs do an amazing job and fulfil an important role in the tertiary education system.”

With over 150 people present, including the Minister of Education, politicians from the four main parties, chief executives and representatives from government agencies, WDCs, and CoVEs, exhibitors from complimentary industries, and delegates from PTEs, the conference provided a wonderful opportunity to learn, share and network.

98% of respondents said they were very satisfied (highest) or satisfied with the conference with newtworking being the most-liked aspect, followed by the sessions/speakers

Dispute Resolution Scheme

The Ministry of Education has announced that the work on the combined International and Domestic Dispute Resolution Scheme (DRS) has been completed and that the rules come into effect on Jan 1 2024. You can see the

The Minister has appointed Fairway Resolution Ltd to operate the combined scheme. Fairway already operate the international scheme (istudentcomplaints)

Impact of UFS on PTEs

We have always argued that the UFS has negatively impacted many PTEs, even though we are told in response that the PTE sector as a whole has received more funding

While this may be the case, in our first meeting with the Minister back in March, we emphasized that the biggest challenge to the sector was funding. She subsequently requested information from TEC which confirmed what we knew anecdotally - that only 37% of PTEs actually received more baseline funding (Learner and Delivery components), and **63% received less**. (Some possibly received the same amount). 43% of PTEs had a decrease of 10% or more

We continue to argue the case with the Minister, TEC and MoE and to push for policies that reflect the 'critical' role (their words) of PTEs in tertiary and vocational education

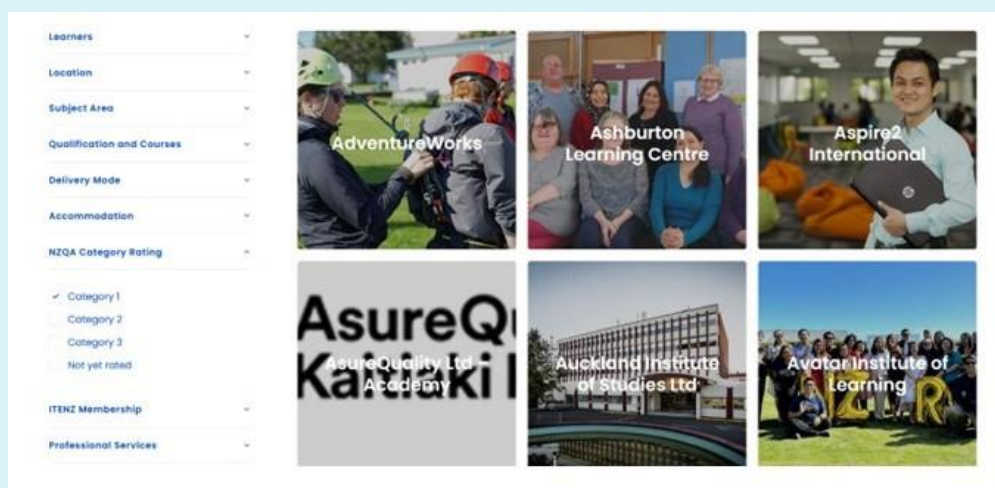
