Message from the Chair



Welcome

Since our last newsletter the Peak Bodies Meetings have been held and a number of issues raised. We had, as a whole International sector, the first opportunity to hear from Minister Penny Simmonds on her thoughts for International Education. We are still hopeful to meet with Minister Erica Stanford in her role as Minister of Immigration.

Although Education NZ has reported further recovery of the International education sector with international enrolments at 46,109 as at early October 2024, this is still only 76% of October 2019, so we have a long way to go. Positive Immigration NZ settings around visa approvals and processing are a key component of enabling providers to reach pre-Covid levels. We were advised that improvements are being made with processing, so that is positive. However, the government has a long way to go to enable providers to meet the government's goal of doubling export

income, of which International education is a part.

The Board are actively involved in the review of the IQAF and we encourage you all to put in individual submissions. At the Peak Bodies Meeting, we highlighted the need to combine the annual Code of Practice self assessment with the self review replacing the EER so we are not duplicating compliance.

We have also stressed the need for a foundation learning review to be considered with urgency for 2025. It is something we have previously raised with the Minister and will do so again.

We have also raised the issue of the aviation funding cap in respect to EFTS and student loans, following the recently published report on behalf of Ringa Hora and the Aviation Industry Association of NZ. So far there has not been any action taken by Government in response to the findings

With our final Board meeting on the 5th December we will be working on submissions and finalising the draft changes to the ITENZ constitution.

On behalf of the Board we wish you all a Merry Christmas and a Happy New Year. Enjoy your break!

The November peak bodies meetings were held this week.

The cross-agency meeting with MoE, NZQA, TEC, MSD and WDCs included discussions on L&N issues, financial viability, investment plans, the Code, compliance work and aviation caps.

In the afternoon international meeting, we heard from Minister Simmonds, who is aware of the visa and PSWR issues. How we double international education under current visa settings remains a core area of interest for providers. New ENZ CE, Amanda Malu, presented her high level plans for ENZ and we heard from INZ, MBIE, NZQA and MFAT officials.

Full minutes will be out in the next couple of weeks.

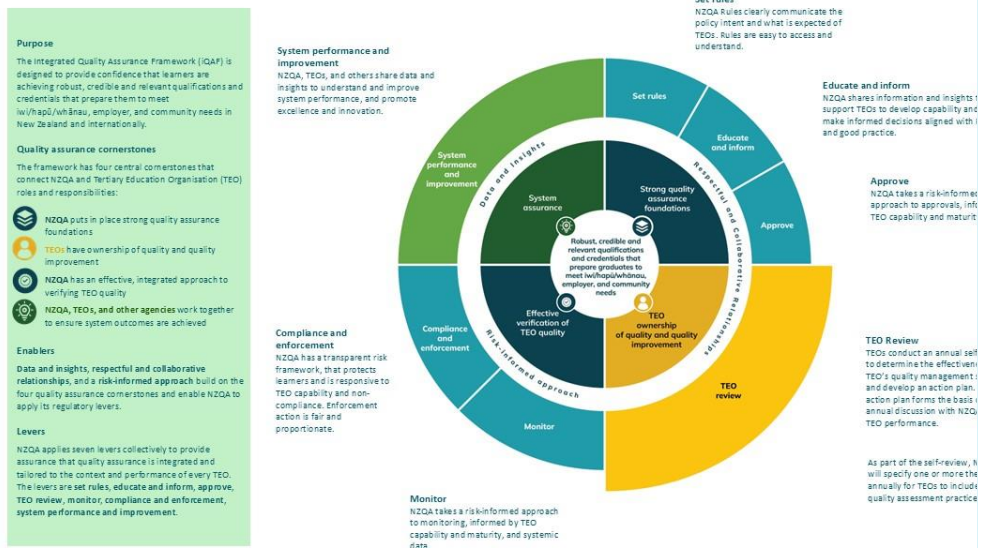
Consultations

Public perception of international education

Education New Zealand has published its [Survey of the Public Perceptions of International Education](#), which shows that more than three quarters New Zealanders believe that the country should host the same or more international students. 82% agree that international students contribute to our cultural diversity, with 79% feeling they help local students learn about other cultures and ways of life, as well as contributing to local business during their studies.

Australian caps on international education in doubt

The Coalition opposition in Australia [has signaled it will oppose the bill](#) to impose the caps on international students in Australian institutions, meaning the bill may not go through. The Coalition are not completely opposed to some form of caps, however, so there is still considerable uncertainty over what may happen.

This may have some impact in New Zealand as the prospect of caps on

international students had seen increased interest in New Zealand.

Workforce Futures Fund

In September we noted the creation of a new fund for workforce development. Details are now available on <https://workforcefuturesfund.nz/>

The Workforce Futures Fund | Tahua Rāngaimahi Anamata, will open in mid-February 2025 for applications from these industries: Aged support; Cleaning; Disability support; Home and community health services; Mental health and addiction support; Social services; Urban pest management; and Youth work.

Applicants need to work in those industries or have strong support from sector bodies.

\$15m is available that will be spent down via two grant rounds each year over the next three years. This timeframe may change based on the number and type of applications. The second grant round will open in August 2025.

The fund's purpose is supporting innovation in workforce development and demonstrating the value of strategic investment. It will fund greater use of

technology; collaboration across industries; and improved service delivery through:

- Vocational training, workforce development and education
- Programmes, information and resources to promote best practice and continuous improvement and
- Attracting people to work in the sectors and workforce retention.

It will prioritise applications that benefit:

- Māori;
- Pacific; and
- Disabled People.
