ITENZ Tutor of the Year Award, sponsored by Office Max

ITENZ Board meeting with Minister Simmonds

Prior to the ITENZ Conference the Board had a half-hour meeting with Minister Simmonds in which they discussed the future role of PTEs under

VET reforms, financial viability settings, doubling international education earnings and aligning immigration settings, YG, and NEET funding.



Peak bodies meetings

Minutes for the Cross-agency and International Peak Bodies meetings are in the [Member resources](#) area of the website.

The Cross-agency meeting included a Q&A session with Gillian Dudgeon (TEC) and Katrina Sutich (MoE), and updates on the data system refresh, financial viability, training scheme/microcredentials, skill standards, fees free and other topics, which you can read about in the minutes

The International meeting included an MBIE policy update and updates from INZ, NZQA, MoE and ENZ. Minutes and individual reports are on the website.

The International minutes also include notes from a workshop the previous day with INZ and facilitated by ENZ, which focussed on ways in which we could improve visa approval rates. The workshop generated a lot of ideas that providers, agents and INZ could do. Everyone agreed that a policy discussion is also required.

Participants agreed that the workshop had been a useful first step and that the next steps will be grouping ideas and comments into themes, prioritising them and working on actions so that we can see some improvement in application outcomes.

ITENZ constitution

The ITENZ Board is in the process of revising the constitution (ITENZ Rules) to comply with the new Incorporated Societies Act and hopes to have a draft ready for members to respond to at the upcoming AGM.

Ministry of Education consultation: realising the potential for technology to support personalised and tailored learning in the future

The Ministry are now consulting on the topic of their next long-term insights briefing: *exploring how the education system can be flexible, adaptable, and relevant to the diverse population it will serve in 10-20 years by realising the potential technological changes offer for more personalised and tailored learning.*

Their briefing states: *We are looking at this because we know that the child and youth population of Aotearoa is becoming increasingly diverse. We also know that future technological changes are likely to shape how and*

where learning happens and what skills and knowledge children and young people will need to succeed in the future.

We are interested in your views on the opportunities for the future use of technology in our education system and the challenges we may need to consider. Your comments will help inform our thinking as we develop our briefing on this topic.

NZQA has published [Guidelines for listing skill standards](#) (which you can also find on the Members page).

The document has been updated since last year and provides background and design principles as well as processes. NZQA plans to update this in the future with more information on expectations for standard setting bodies collaboration, the relationship between skill standards, micro-credentials and qualifications, and transition arrangements for unit

standards.

Workforce Futures Fund

A new fund, the Workforce Futures Fund | Tahua Rāngaimahi Anamata, will open in February 2025 for applications to support initiatives in specified industries.

The fund will grant to workforces in: Aged support; Cleaning; Disability support; Healthcare services; Home and community health services; Mental health and addiction support; social services; Urban pest management; and Youth work sectors.

The \$15m fund will be spent down via two grant rounds each year over the next three years. This timeframe may change based on the number and type of applications.

The fund's purpose is supporting innovation in workforce development and demonstrating the value of strategic investment. It will support greater use

of technology; collaboration across workforces; and projects that build or improve service delivery. It will fund:

- Vocational training, workforce development and education;
- Programmes, information and resources to promote best practice and continuous improvement; and
- Attracting people to work in the sectors and workforce retention.

The aim is for projects that have industry-wide impact and there may be opportunities for members in these sectors to collaborate on proposals.
